Achievements and Activities

In November the charity had Fire Detection and Emergency Lighting installed throughout its premises with funding provided by Scottish & Southern Electricity. The charity was also granted local planning permission to provide an alternative heating system in the church which will be installed early next year. Funding from our Scottish Synod has been made available to assist with this. The charity is currently in the process of the provision of disabled toilet facilities in its premises.

The charity will be providing trustee representatives to the 1st Kirkwall Company Boys Brigade as they have applied to OSCR to become a SCIO.

The charity during the year undertook a full programme of events within the community. Its hall was used by various local organisations throughout the year. In particular we hosted weekly meals throughout the summer months in conjunction with the 3rd sector and Voluntary Action Orkney. They also provided an Adult Befrienders club throughout the year. Our hall facility was used during Dementia Awareness Week. The charity DentAid has free use of our facilities as well as various local groups who look to fundraise. During the month of September the charity provided lunches in for the Orkney International Science Festival which is an annual event.

The charity undertakes financial support to a local charity each year. This year we donated monies to the Orkney Deaf Children's Society. The charity also financially supports the 1st Kirkwall Company Boys Brigade annually as they are closely associated to the church.

The charity continues to support the local foodbank with 64.3 kgs of food donated.

Trustees' Remuneration and Expenses

No trustees received any remuneration from the charity.

Reserves

As a result of the surplus of £17,289 for the year, the charity held unrestricted funds of £47,862 at the year end. The trust also holds the title deeds to the Peedie Kirk and Manse buildings. The trustees consider that the funds held will enable the charity to continue to operate through the forthcoming year.
